Participants are responsible for all tables, chairs, tents, **silent** generators (between 50-65 dB), and supplies needed for booth set-up. Electricity is **not** provided.

Completed retail vendor applications including required documentation and fees **must be received by Monday, October 10, 2022**. Spaces will be assigned on a first come, first serve basis. In the event of inclement weather, **NO** fees will be refunded. The event will be held RAIN or SHINE.
